DPAS Rating, The vendor shall comply with the DPAS requirements as specified at http://guidebook.dcma.mil/38/dpas%20guidebook.htm

DFAR Compliance, The vendor shall comply with all FAR and DFAR requirements as they apply to this purchase. Further guidance at http://farsite.hill.af.mil/search.htm

Certifications: (All certifications will be supplied with material when indicated.)

- 1. <u>Mill</u>, The vendor shall acquire and maintain all certification required for the product being supplied.
- 2. <u>Chemical & Physical</u>, The vendor shall acquire and maintain all certification for the product being supplied.
- 3. **Process**, The vendor shall acquire or produce and maintain all process related certification.
- 4. <u>C of C</u>, The vendor shall produce a C of C for each shipment of product.
- 5. <u>Mercury Free</u>, The vendor shall acquire, produce and maintain all certification for the product being supplied.
- 6. <u>MSDS</u>, The vendor shall acquire, produce and maintain all certification for the product being supplied.

Government Inspection:

- 1. **GOV**, The government reserves the right to inspect at the vendors facility. In the event this right is exercised you will be notified in writing.
- 2. **GSI**, Government inspection is required prior to shipment from your plant. Upon receipt of this order, promptly notify the Government agent that normally services your facility, so that appropriate planning for GSI can be accomplished.
